- 22. An 18-year-old male previously diagnosed with bipolar disorder is brought by his best friend to the emergency department of a rural hospital near his grandparents' house. The best friend reports that the patient "is completely wild—he just won't stop—he's going to kill himself on the slopes!" he confided in his friend that he has been having suicidal ideations for a long time and has attempted twice most recent a week ago and he is still having strong urges of harming himself. He also excessively uses Alcohol together with other substances and indulges in risky behaviours. The patient shows evidence of intoxication and is irritable but cooperative during the initial interview in the emergency department. His vitals are within normal limits and are stable. No abnormalities are found on physical examination. The psychiatrist on call realizes that he has been managing his grandfather and wonders whether it would be ethically right to take him up as his patient as well. Though goes ahead to assess the patient recommends for all necessary investigations to be done and recommends for an involuntary admission, as the patient had declined admission.

- a) Highlight the 4 ethical codes that are in play in the above scenario? (4 marks)
- b) Should the psychiatrist have interviewed and assessed the patient at the ER? (2 Marks)
- c) Should the psychiatrist continue to be the patient's doctor? Explain (2 marks)
- d) Comment about confidentiality in this case. (2 Marks)
- e) Outline the nine NAADAC Principles of the counselling profession- (10 marks)
