# **Question 1**

#### **Question 4**

Discuss, and provide examples of aspects of professionalism in Health Professions practice in terms professional codes of conduct, professional codes of ethics, professional competencies, professional roles and responsibilities **(20 marks)**.

- c) Discuss the purpose of collaboration of the Inter-University Council for East Africa (IUCEA) Quality Assurance Member Agencies. **(6 marks).**
