C)Describe any five (5) forms of fraud commonly reported in health care highlighting their mitigation measures (5mks)

D)Read the following case and answer the question that follow:

In August 2014, M was admitted to the X County Hospital for induced labor just weeks after a national directive instructing all public health care facilities to offer free maternity health care services was issued by the President. Despite the directive, M had to purchase her own medicine and basic necessities.

After taking the medicine, M was not physically checked or monitored by HCP and was informed that if she needed medical attention, she would have to walk from the labor ward to the delivery room herself. In the maternity ward, she was repeatedly slapped and verbally abused and left to deliver her baby on the concrete floor while entering in and out of consciousness. She was ordered to walk to the delivery room, still unaided. She was released with her baby the following day.

Question: what are legal and ethical issues in this case? Would the patient be justified to sue? Explain your answer (7mks).

Mr **K** claimed that was in breach of kenya's data protection Act (DPA) and the way his subsequent complaint regarding the matter was handled had made worse a pre-existing paranoid personality disorder and prevented him from working.
