- 2. Carol has been advised to continuously monitor her blood pressure after being diagnosed with hypertension or high blood pressure. List any FOUR uncontrollable risk factors which predispose a person to hypertension. (4 Marks)
- 3. Benson is 65 years old and has dementia. He can no longer recall events in the present time but can remember past events. Identify any FOUR causes of dementia. (4 Marks)
- 4. Individuals diagnosed with chronic conditions are required to feel supported. State FOUR ways of supportive counselling for cancer clients. (4 Marks)
- 5. Mary is a medical conditions counsellor stationed at the level 5 county hospital and has a client who is eight years old and diagnosed with HIV. State FOUR ethical considerations Mary should be mindful of when dealing with the child. (4 Marks)
- 6. Jack, a medical conditions counsellor, has specialized in using cognitive behavioural therapy (CBT). Identify FOUR significant factors of the CBT model that a counsellor needs to consider. (4 Marks)
- 7. Jason, a medical conditions counsellor, has a client with diabetes. Mention FOUR aspects he would consider when developing a counselling treatment plan. (4 Marks)
- 8. The medical conditions counsellor recognizes that referral is sometimes necessary. Identify FOUR situations when a referral can be done. (4 Marks)

 - c) Discuss FIVE stages of grief according to Elizabeth Kubler Ross. (10 Marks)
- 12. Clive has chronic coronary heart disease and has been visiting the medical conditions counsellor Jane, for a year. He enjoys his visits and has developed a liking for Jane.
 - a) Explain FIVE techniques Jane can use to terminate this client counsellor relationship.
