- 1. The assessment process in counselling therapy is essential for diagnosing mental disorders. Identify FOUR mental disorders that a counsellor can assess in a client. (4 Marks)
- 2. Most counsellors use a psychological test to assess a client. Outline FOUR characteristics of a good test. (4 Marks)
- Penny is a registered clinical supervisor and has been providing clinical supervision to counsellors for the past three years. Name FOUR responsibilities of a counsellor supervisor.
 (4 Marks)
- 4. Termination is challenging for most counsellors, especially for beginning counsellors. State FOUR ways in which one can terminate an assessment session. (4 Marks)
- 5. Personality theories help us understand the personality dynamics in different people during their lifespan. Name FOUR personality theories. (4 Marks)
- 6. A counsellor needs to have self-care strategies to remain competent. Outline any FOUR purposes of self-care for a practising counsellor. (4 Marks)
- 7. An assessment venue is used as a therapeutic tool during assessments and even counselling. List FOUR items a counsellor needs to have in the counselling room during the assessment.

- 8. Claudia conducts Counselling assessment at the Fariji counselling centre. However, she is required to perform this task in other settings beyond her traditional counselling centre. State FOUR other settings where counselling assessment can be conducted. (4 Marks)

- 11. Claudia is a 22-year-old college student pursuing a diploma in nursing. She is a 1st born in a family of 5. Her father, the sole breadwinner of the family, passed on when she was in form four. Her mother has sold some property for her to go to nursing school, and two of her sisters are waiting to join college after Claudia finishes school. She feels she has to perform in school, get a job and help her family. She has started using bhang and alcohol to help her focus and sleep well. This has had the opposite effect, as her grades have dropped, and she has failed 5 exams in her last trimester. Claudia has locked herself in her room; she does not want to see anyone. She has switched off her phone, and her last social media status was "I fought a good fight, and I lost". She has not been eating and feels fatigued, hopeless and helpless.
 - a. Identify ONE assessment tool that you would use to help diagnose Claudia. (2 Marks)
 - b. Describe FOUR causes of mental disorders amongst college students. (8 Marks)
 - c. Explain FIVE symptoms that may indicate that Claudia is not okay and needs counselling.
