- 1. Project sustainability plan is a requirement for every project manager implementing a project. State FOUR reasons for preparing project sustainability plan (4 Marks)
- 2. Project managers are required to conduct value analysis after the completion of the project cycle. Highlight FOUR reasons for conducting value analysis. (4 Marks)
- 3. Benefit assessment is determined before handing over the project. List FOUR reasons of conducting project benefit assessment. (4 Marks)
- 4. When a new project is being initiated project managers are required to prepare a business case by project funders. Enumerate FOUR reasons of preparing a business case before initiating a new project. (4 Marks)
- 5. Project managers are required to involve stakeholders in project review meetings. State FOUR reasons why stakeholders need to be involved in project review meeting.

6. Before project closure, project managers are required to document lessons learnt throughout the project cycle. Highlight FIVE reasons of documenting lessons learnt

11. James has been assigned a role of a project manager with a local Non-Governmental Organization. One of his roles is to guide the project implementation until it is completed and handed over to the stakeholders. When the project is completed, he is supposed to prepare a final project closure report. In the process of compiling the final project closure report, he is supposed to look at the original project guidelines to ensure that project was completed as per the plan. He is also supposed to take note of the project deliverables, compile invoices from the suppliers who supplied various goods and services during project implementation. James should also consider the resources released to the project beneficiaries and conduct detailed performance reviews from each completed project phase. Before handing over the report he should also get feedback from senior management to determine whether the outcome of the project has been achieved.

  - b) Explain FIVE challenges he may encounter when preparing project sustainability plan (10 Marks)
- 13. Archiving project documents is an important aspect which is carried out during project closure.
  - a) Discuss FIVE documents which need to be archived. (10 Marks)
  - b) Explain FIVE reasons why project documents are archived (10 Marks)
- 14. Project managers are required to ensure intellectual property and copyrights are documented before handing over a project.
  - a) Explain FIVE benefits of documenting intellectual property rights (10 Marks)
  - b) Discuss FIVE challenges which may occur if intellectual property and copyrights are not documented during handing over of the project. (10 Marks)
