# SECTION B (60 MARKS) Answer Question 11 (compulsory) and any other two questions

11. In Kenya public procurement is governed by public procurement and disposal act 2015. Procurement managers in Kenya are supposed to adhere to the provisions of the act when ensuring goods and services are supplied. Supply chain managers have a duty to establish a procurement cycle which will guide them in procuring goods and services for that given financial period as per the approved procurement budget. In identifying the budget cycle, procurement department need to come up with procurement plan, which will define all the goods and services to be supplied within that given procurement period. After developing procurement plan, procurement professionals need to determine contract requirements definition and float tenders in order to source goods and services for the organization.

When suppliers respond to tenders and places the bids, the procurement manager has to convene an evaluation committee which will evaluate the tender and select the qualified bidder. When the qualified bidder is identified he/she is awarded a contract to supply goods and services through a letter of offer.

When the qualified bidder is given a letter of offer, he is supposed to accept the terms of contract through notifying procurement manager by signing a letter of acceptance. When this exercise is over and the contract awarded the contract is awarded to the supplier, the suppliers goes ahead to supply goods and services to a project organization. The procurement department has a duty to manage the supply contract to ensure goods and services of specified quality are supplied.
