- 12. In the semi-arid county of Kajiado, Kenya, a community-driven agricultural project has emerged to address pressing challenges faced by local farmers. The initiative, spearheaded by the Kajiado Farmers' Cooperative Society (KFCS), aims to enhance food security, increase household incomes, and build resilience in the face of climate variability. KFCS launched the agricultural community project in 2019 in response to recurrent droughts and limited access to markets, which were severely impacting farmers' livelihoods. The project's primary objectives include promoting sustainable farming practices, introducing drought-resistant crop varieties, and establishing market linkages for improved income generation. To tackle the identified challenges, KFCS adopted a multifaceted approach. First, the project conducted training workshops and field demonstrations on climate-smart agricultural practices and farmers were equipped with knowledge and skills to adapt to changing environmental conditions. Recognizing the importance of diversification, the project introduced drought-tolerant crops such as sorghum, millet, and pigeon peas alongside traditional crops like maize and beans. Given the region's limited rainfall, the project promoted rainwater harvesting techniques and installed community irrigation systems to ensure year-round crop production. KFCS also facilitated market linkages by establishing partnerships with local markets. Unpredictable rainfall patterns and prolonged dry spells posed a significant challenge to crop production and water availability for irrigation. Farmers faced constraints in accessing quality seeds, fertilizers, and agricultural inputs essential for improving productivity. Fluctuating market prices and some farmers lacked technical knowledge and skills required to adopt modern farming techniques and technologies and inadequate market infrastructure affected farmers' ability to sell their produce profitably. Limited access to credit and financial services has hindered farmers' ability to invest in improved farming practices and equipment. The project has increased crop yields and diversified production has enhanced food security. Farmers have adopted sustainable farming practices, leading to improved soil health and water management. Market linkages have enabled farmers to access higher-value markets and receive better prices. The project has strengthened community cohesion and resilience, with farmers actively participating in decision-making processes and sharing knowledge among peers.
