Sarah, a10-year-old girl was referred by her school counselor to Masaa Care Center which is a
local child welfare agency. This referral arose from concerns regarding Sarah's frequent
absences from school, behavioral problems in the classroom, and indications of potential neglect
at home.

Upon receiving the referral, a child welfare case worker conducted a thorough evaluation of Sarah's circumstances. This assessment involved interviews with herself, her parents, her teacher, and other relevant individuals, as well as a visit to her home.

Following the assessment, the case worker collaborated with Sarah, her parents, the school staff, and various service providers to create a tailored care plan aimed at addressing Sarah's specific needs. This individualized care plan was put into action over a period of six months, during which regular reviews were conducted to monitor progress and make necessary adjustments. Throughout this process, the case worker maintained close oversight of the implementation of the care plan. They facilitated coordination among all involved service providers and actively engaged both Sarah and her family to ensure their participation in the process.
