- 1. a. Explain the concerns in RH with regards to bioethics. (3 marks)
  - b. Identify and examine two ethical considerations related to access to contraception. (5 marks)

c. Demonstrate the ethical challenges surrounding assisted reproductive technologies

(ART). (5 marks)

d. Discuss the ethical conflicts that may arise from exercising reproductive health rights.

(4 marks)

e. Analyze reproductive health challenges for vulnerable populations, such as low-income women or individuals with mental or physical disabilities. (4 marks)

f. Propose two strategies to ensure reproductive health services are delivered ethically

and equitably in Low- and Middle-Income countries (LMCI). (4 marks)

# SECTION B: ANSWER <u>ANY THREE (3)</u> QUESTIONS (75 MARKS)

- 2. You have been asked to present to the University board council the concept of research integrity and its significance in scientific inquiry.
  - a. Identify the key principles that underpin research integrity and analyze the potential consequences of research misconduct on both the scientific community and society at large. (15 Marks)
  - b. Provide examples to illustrate your points in order to provide clear policy direction for the Council. (10 Marks)
- 3. Consider the research regulation framework in Kenya, focusing on the legal issues that arise in conducting research involving human participants.
  - c. Discuss the role of the National Commission for Science, Technology and Innovation (NACOSTI) and other relevant bodies in overseeing research ethics. (15 Marks)
  - d. Analyze the challenges faced by researchers in complying to these regulations and the implications of non-compliance (10 Marks)
- 4. Public health research in emergencies:
  - a. Explain the ethical considerations surrounding public health research in emergencies, pandemics, and disaster situations? (13 Marks)
  - b. What unique challenges do researchers face in these contexts? Critically evaluate these challenges and provide examples for your position. (12 Marks)

- 5. Philosophy and bioethics
  - a. Discuss the philosophical basis of bioethics. (10 Marks)
  - b. Compare and contrast the main ethical theories that inform bioethical decisionmaking. Provide examples to illustrate your points. (15 Marks)
- 6. The slippery slope
  - a. Illustrate the concept of the "slippery slope" in bioethics and give examples. (12 Marks)
  - b. How can both of these two concepts of the "slippery slope" affect gender considerations in bioethical discussions in research or clinical practice? Give examples (13 Marks).
