- 1. You are a public health official in a country with a high population growth rate. The government has introduced a population management policy that promotes smaller families. How would you implement this policy in rural areas where larger families are the norm, without causing social resistance? (7 marks).
- 2. Population management policies often face different challenges in urban and rural areas. How would you adapt family planning services to meet the unique needs of both urban and rural populations in your country? (8 marks).

- 3. In some communities, adolescents and unmarried individuals may face barriers to accessing contraceptives. How would you address these challenges while ensuring that everyone has the right to make informed reproductive choices? (15 marks).
- 4. In countries where legal frameworks restrict access to certain contraceptives or require spousal/parental consent, how would you advocate for policy reforms that promote reproductive rights and autonomy? (15 marks).
- 5. In countries with declining fertility rates, how can population management policies support individuals who want to have children, while also ensuring that contraceptive rights are upheld for those who do not? (15 marks).
- 6. A healthcare provider is recommending long-term contraceptive options to women in a low-income community. How would you ensure that informed consent is ethically obtained, especially when some women may have limited health literacy or face social pressure? (15 marks).
