12. Sidai Community Conservancy is a project that was started by the government as part of a policy aimed at addressing climate change and global warming. The project involves distribution of tree seeds to community members who sow them in seed beds and resell the seedlings back to the government for distribution. The role of the government in this project is to provide funds to buy seedlings and also carry out capacity building for the farmers. There is a committee which is entrusted to be a link between the community and the government. In the course of the programme, allocation of funds by the government delayed hence, they could not put the seeds in the nursery on time. The community members started losing interest in the project. This made the community members to eventually stop participating in the project. Upon investigation, it was realized that the committee had misappropriated funds and also misused resources which led to the government reviewing the project policy on climate change.
